Message from SAILS' Executive Director: Kitty L. Brietzke, J.D.

Citywide Celebration of ADA Landmark Legislation

On July 26, 1990 President George W. Bush signed into law the most comprehensive piece of legislation ever written for persons with disabilities-The Americans with Disabilities Act (ADA). The ADA is really civil rights legislation for families with disabilities. We must not forget the original intent of ending unjust segregation and exclusion of persons with disabilities from our "mainstream" society.

We should all remember and thank the thousands of people who made up the "disability rights movement" and whose efforts have helped to change the lives of thousands of persons with disabilities today. These historical "disability advocates" sought justice in our American courts and with Congress to ensure that people with disabilities would be included in all aspects of living. Many of these advocates told their own very compelling stories of discrimination to Congress during the ADA legislative process. They succeeded by way of their unwavering commitment to help people with disabilities receive the justice they deserved (Bush).

On Friday, July 31, 2009, San Antonio Independent Living Services (SAILS) invited the community to attend the 19th Annual Americans with Disabilities Act (ADA) celebration. The ADA celebration began about 8:00a.m. with hundreds of excited folks gathering at the San Antonio's Mercado for the Unity Pride Stroll over to 401 Villita for the day's events. Employees and volunteers from various organizations carried banners along the march towards Villita where about 45 vendors were awaiting the arrival of hundreds of guests. Organizations such as the Alamo Service Connection (ASC), AmeriGroup Corporation, Gordon Hartman Family Foundation, Goodwill Industries, AnyBabyCan and San Antonio Lighthouse for the Blind proudly showed their continuing support for the ADA.

After the celebration began at Villita Hall, SAILS presented AnyBabyCan's Executive Director, Dawn Dixon an award for Disability Organization of the Year. Next, our keynote speaker, State Representative Joe Farias provided words of inspiration and motivation to all to continue to advocate for "the rights of all persons with disabilities." The crowd applauded him for his dedicated service to the community. SAILS presented a plaque to him for Public Servant of the Year. Many other individuals and community organizations were also awarded plaques by SAILS Director of Programs and Resource Development, Gloria Banik and State Independent Living Council member, Randell Resneder. Randell flew in from Lubbock to join SAILS

Jarrell credits GAP for giving him the support and consistent affirmation needed to achieve success. During a recent interview, he stated: "I have come a very long way in my struggle for independence. Ms. Blake has been very supportive because she gave me the direction and affirmation to finish school this year".

GAP has been a "life safer" for Jarrell who struggles with physical, emotional and learning disabilities. The workshops have served to motivate him especially the one on writing realistic goals. Jarrell said this class helped him to focus on one area to accomplish every objective until I reached my target.

Anger management has also been an issue for Mr. Kane. He proudly told me the session on this topic was useful "because I listened to the other people who have the same problems. I realized I could control my emotions and behavior. He wrote a goal on anger management and is meeting it on a daily basis.

SAILS provides a monthly bus pass making it possible for Jarrell to travel independently in the community. He now attends classes and is able to take public transportation to school, library and the movies. He continues to strive for self sufficiency.

We, at SAILS, extend our congratulations to Jarrell. He not only graduated from high school with honors, but is an outstanding GAP participant.

The first few months of 2009 have been busy for the Specialized Telecommunications Assistance Program (STAP) at SAILS. The many presentations that staff have done to spread the word about STAP in the community have been very productive. STAP has received many new referrals for people needing equipment in San Antonio and the surrounding counties. STAP staff continue to visit consumers and provide presentations to the community.

STAP staff look forward to reaching many new consumers, but also are pleased when we are able to serve long-time consumers of SAILS like Jessie Rodriguez. Jessie began coming to SAILS in April of 2007 for braille instruction with Casey Hamilton. Jessie has also received services from Sandie Flanagan who referred him to STAP. I met with Jessie and his parents to complete a STAP application for a specialized telephone for Jessie. Jessie was a little apprehensive at first about applying for his new phone, however, now, Jessie reports that he has received his phone and is very pleased with it and the independence it provides him. Jessie continues to come to SAILS and works very hard every week during his sessions with SAILS staff.

Jessie's story is a perfect example of the importance of STAP and how, simply, having access to the telephone is a privilege that many of us take for granted. Being able to use the telephone provides people with their connection to the world and a sense of independence.

SAILS' Technology Workshop

Benefits Consumers as well as Professionals

SAILS had a super "turnout" for our Assistive Technology Workshop on April 22, 2009. Consumers were provided with the most up-to-date information on technology covering a wide range of needs for persons with disabilities. Workshop participants learned about the latest video relay phone technology benefiting persons who are deaf from Robert Guintoli of Sorenson Video Relay.

Lori Crownover of SAILS, also spoke about SAILS' Specialized Telecommunications Assistance Program (STAP) which provides free phone equipment for Texas residents who have disabilities. Mr. Antonio Chavez, a workshop participant who is deaf, was happy to report that he just received his new Two Way Pager from SAILS' STAP. This has provided him with the technology to communicate via text messaging.

Other presenters were Margarita Vasquez and Sara Fillipone of Communications Services for the Deaf (CSD) which provides advocacy and resources for persons who are deaf and hard of hearing.

Diana Rodriguez of the Lighthouse for the Blind spoke about her services as a Rehabilitation Specialist and described some of the latest advances to assist persons with visual impairments.

Linda Mueller from The Department of Assistive and Rehabilitative Services (DARS), also presented valuable information on their rehabilitation services separate from their vocational program. Although DARS does have a waiting list, once a person is selected from the waiting list, they are able to access equipment and services which help them gain greater independence.

Finally, Randi Hoo-Mook represented Project Mend which provides recycled medical equipment for those who cannot afford to purchase new equipment. Project Mend maintains an inventory of equipment such as walkers, wheelchairs, shower chairs and more for those in need.

The Assistive Technology Workshop was well received by consumers with many types of disabilities. It was also a great opportunity for professionals to network and, in turn, develop more efficient ways to assist consumers.
